ABOUT POLK VISION

In 2004, citizens from across Polk County, led by private, public and civic leaders, joined forces to address critical issues facing our community and to develop a common purpose. Focus groups, town hall meetings and task forces were engaged in a nine-month process to gain insight into the priorities that unite and challenge our community. Together we examined our strengths and weaknesses, and developed a long-term vision with strategic solutions and countywide benchmarks. The strategies were adopted by public and private organizations, large and small, with a common goal to create our desired future.

Over the years, Polk Vision has remained vital and relevant through the continued engagement of citizens by conducting public meetings, forums and roundtable sessions. A formal "refresh" of the Vision was performed in 2010 which resulted in updated strategies and adjusted benchmarks. In the fall of 2014, with the encouragement of visionary supporters, we became members of the national collective impact organization Alignment USA. Through this relationship, we have integrated new structure, process and technology with the Polk Vision founding principles and areas of focus.

Polk Vision is the LEADing collective impact organization serving the entire Polk County community. We provide central coordination to align the work of hundreds of dedicated volunteers through partnerships of public, private and civic organizations working collectively to make the shared vision of improved community prosperity for Polk County a reality!

This process ensures that multiple approaches are considered. For example, the Literacy Team links their work in K - 5 childhood education to increasing high school graduation rates — demonstrating the importance of collective impact when addressing complex issues.

LITERACY LEAD TEAM

- Literacy Team Meeting

Based on Polk County Schools data, in 2015, only 40 % of Kindergarten students came to school proficiently ready; scoring 10% less proficient than the previous year. Also, during the 2015-16 school year, only 45% of Polk County Public School students in grades 3-10 scored proficiently on the English Language Arts portion of the state assessment, up just 1% from the previous year. The goal of the Polk Vision Literacy Team is to increase student literacy proficiency by 2% per year at each grade level.

National research has shown that increasing literacy rates in elementary grades has lasting effects, including higher graduation rates, college attendance and success rates. In order to support families in understanding how to assist their students in improving reading and comprehension, the Literacy Team is embarking on the creation of a Literacy Directory.

The Literacy Directory will promote a more literate community by providing information about resources available for students and their parents. Directory content will encompass activities, programs or services related to reading, writing, communication, technology, speaking, performance, or additional literacy-related topics.

Many of our youngest students miss 10 percent of the school year - about 18 days a year or just two days every month. Chronic absenteeism in kindergarten, and even pre-K, can predict lower test scores, poor attendance and retention in later grades, especially if the problem persists for more than a year.





2 in 10 low-income kids miss too much school. They're also more likely to suffer academically.



2.5 in 10 homeless kids are chronically absent.

ATTENDANCE LEAD TEAM

During the 2015 - 2016 school year, 3,334 students were absent 21 or more days in grades Kindergarten - 5th Grade. One in 10 Polk County kindergarten students missed at minimum 10% of the school year - approximately 157 hours of instruction time in the classroom.

Identified as a key need by the Polk County School District's Strategic Plan, the Attendance Team is committed to promoting awareness of the importance of school attendance within the school district and the community. Attendance plays a critical role in achieving academic success and can impact student achievement as early as pre-K.

Attending school regularly is essential to students gaining the academic and social skills they need to succeed. Reducing absenteeism is a simple, cost-effective, but often overlooked strategy for improving academic performance. Starting as early as preschool and kindergarten, chronic absence can leave third graders unable to read proficiently, sixth graders struggling with coursework and high school students off track for graduation. Chronic absence is especially problematic among students living in poverty who are most likely to have poor attendance over multiple years and least likely to have the resources to make up for the lost time in the classroom.⁴

INFRASTRUCTURE LEAD TEAM

As the word cloud above suggests, the topics that fall under the umbrella of the Polk Vision Infrastructure Team are varied, ranging from multi-modal transportation to water. The Team has addressed issues such as land conservation, failing lane miles, affordable housing, growth management and broadband. While committed to continuing to monitor these issues, the Team now has an eye on the growing concern for safe routes to school. They have chosen to conduct a comprehensive gap analysis to identify needs for sidewalk improvements on collector roads within a 2 mile radius of Polk County schools.

QUALITY OF LIFE LEAD TEAM

LEAD Team members at Poverty Simulation

In 2015, the number of individuals in Polk County living in poverty was 18.5% - 2% higher than the state average and over 3% higher than the national average. Poverty or a lack of income can have a profound effect on access to basic needs and services and there is often a trade-off or

choice made to meet one need versus another. There is a diminished quality of life for those living in poverty with the detrimental effects ranging from poor nutrition and health to substandard housing and lower academic achievement.

Over the past two years, the Quality of Life Team focused its efforts on deepening their understanding of the contributing factors to poverty and the resources that are available in the community, as well as access gaps that low-income individuals and families are likely to encounter on the road to self-sufficiency. Specifically the Team hosted focus groups and LEAD forums on a variety of topics including Housing, Health, Hunger, and Elderly Services. The Team assisted in coordinating a "Poverty Simulation" along with eight other agencies in a UF/IFAS led educational event, to help policy makers from around the county better relate to obstacles families face in addressing daily needs.

Moving forward, the Team will continue to build awareness in the community of poverty and related issues impacting our citizens quality of life. Plans are underway for a series of focus groups and LEAD forums on additional topics beginning with Behavioral Health.

BENCHMARK

By 2030, decrease the percentage of individuals in poverty to consistently be below the State of Florida average.

In 2015, the number of individuals in Polk County living in poverty was around 2% higher than the State average and over 3% higher than the national average. This gap has widened in the last ten years.

School Age

- Fitnessgram Assessments implemented and conducted in all Polk Schools
- Established 90 School Based Wellness Councils



- Worked with the school district to implement health education into the high school curriculum. The HOPE course (Health Opportunities through Physical Education) was implemented in all high schools and is a graduation requirement.
- 5-2-1-0 Campaign: The Polk County School Board created a proclamation to support 5-2-1-0 education throughout schools. Strategy members assisted with the implementation of messaging in cafeterias, education in health and physical education curriculum, and outreach to parents.



Community Based

- Three local governments, Polk County, the City of Winter Haven and the City of Lakeland, were recognized as Healthiest Weight Community Champions.
- Three communities established free opportunities for physical activity for residents
- Hosted a 2-day Health Impact Assessment workshop attended by a number of local planners, public health and other government officials. Attendees learned how to include health as one of the assessment criteria for community projects.



Primary Care Physician

- Surveyed 353 Primary Care Providers to determine if patients were counseled on Body Mass Index (BMI.)
- Conducted 28 interviews of primary care providers to assess provider's challenges addressing obesity, perceptions of their patients' attitudes towards weight discussions and the impact obesity has on patient care.
- 24 pediatric providers participated in the 5-2-1-0 prescription project. Between March 1 & August 31, 2015 a total of 339 prescriptions were issued identifying a total of 383 commitments.



Worksite Wellness

- Surveyed 87 businesses across Polk County to collect information on wellness programming.
- 45 businesses requested assistance from this strategy throughout the 3 year initiative.
- 36 new wellness initiatives have been implemented in Polk County.



Higher Education

- Three Polk County Institutions of Higher Education have collaborated to improve wellness offerings to students on their campuses.
- One university established its own wellness committee based on the influence of this Initiative.

PRIMARY CARE LEAD TEAM

Pediatricians and other primary care providers play an important role in educating families about healthy lifestyle choices. They are in a position to assist families with identifying risk factors such as being overweight or obese that can adversely affect health.

The Primary Care Team is focused on preventing and reducing childhood obesity by partnering with pediatric practices across Polk County in a healthy habits campaign. Physicians are provided with literature and prescription pads used to facilitate conversation with patients and families regarding healthy eating and active living. These prescriptions include a place for the child to designate which healthy habits they will commit to work on and a place for the physician to document the age and BMI percentile of the child. At intervals the prescription data will be collected and compiled for tracking and comparison.

WORKSITE WELLNESS LEAD TEAM

Overarching Team Strategy: Improve the quality of life through the utilization of accessible, high quality, comprehensive, prevention-based community health services designed to promote total well being.

The Worksite Wellness Team works to expand existing and establish new Worksite Wellness programs in area businesses. With leadership and resources provided through Polk Wellness Professionals, these programs offer unique opportunities for promoting healthy behaviors and preventing health problems. Americans spend the majority of their waking hours in the workplace, so the work environment and business productivity are strongly linked to employee health.

The Worksite Wellness Team encourages business to adopt evidence-based programs designed to support employees as they adopt and sustain behaviors that reduce health risks, improve quality of life, enhance personal effectiveness, and benefit the employer's financial success.



Pledged to implement preventative practices that will aid in decreasing obesity rates among school age children, the School Health Team is currently in the planning stages for a program they intend to pilot in 5 Polk County Public Schools. The program is based on the Whole School, Whole Community, Whole Child model which was developed by ASCD and the U.S. Centers for Disease Control and Prevention (CDC), to establish greater alignment, integration, and collaboration between health and education across the school setting. This means aligning and integrating not just policies, but processes and practices that provide for long-term student success.

Phase one of the pilot will consist of two components: Physical Activity and Nutrition. Some of the issues these two components will address include nutrition education for students and families, low cost sources for fresh fruits and vegetables, and safe on-campus facilities that promote physical activity throughout the school day and beyond.

Over thirteen years ago, volunteer community leaders from across Polk County met at United Way of Central Florida to discuss the results of a comprehensive countywide quality of life study. The results were troubling but the volunteers' resolve was strong. They believed in order for Polk County's quality of life to improve a coordinated countywide initiative was necessary.

Today, Polk Vision continues to be the driving force behind important conversations across Polk. Thirteen years since its inception and twelve years since the first community roundtable, Polk Vision tackles countywide issues by systematically identifying issues affecting the lives of all Polk County residents and forging solutions-oriented partnerships.
